CARES Act Emergency Financial Aid Grant Report

First and foremost is the health and well-being of Notre Dame de Namur University (NDNU) students, employees (faculty and staff), and our extended community. NDNU is supporting eligible graduate and undergraduate students by providing emergency financial aid grants from the Higher Education Emergency Relief Fund established by the Coronavirus Aid, Relief, and Economic Security (CARES) Act. COVID-19 Update

In a [Press Conference](#) on October 12, 2020, Gov. Gavin Newsom provided an update to California's coronavirus response. It has been reported that hospitalization rates have decreased 8% over the past two weeks and a 13% drop in COVID-19-positive ICU admissions. The state of California is also looking at upcoming end of year holidays and providing safe recommendations coming soon.

San Mateo is still on California's COVID-19 [monitoring list](#). Individuals who violate health orders, including refusing to wear a face covering in San Mateo County and commercial entities who allow these violations now risk incurring fines after the San Mateo County Board of Supervisors adopted an [urgency ordinance allowing the new penalties immediately](#). As of September 24, 2020, the state of California has announced that indoor restaurants, gyms, movie theaters and places of worship may now open with restrictions in San Mateo County. San Mateo County is currently considered a "substantial" risk level as of today. This means there are 4- 7 new cases daily per 100,000 individuals (a total of 5- 8% positive cases). Current on-campus Access Protocol

Reminder for employees of the protocols in place for when you are on campus.

- **Only come to campus if you are feeling well.**
- Immediately notify Public Safety by email, phone, or in person when you arrive.
